Trinity Labradoodles Dog Guardianship Agreement

, Guardian, is volunteering to take care of the dog as a pet in his/her household. Allison O'Grady, Breeder, is the official sole owner of the dog.

This Guardian is or is not local.

Local Guardians (within about 30 miles of Des Moines): Breeder will provide food to be picked up at St. Francis Veterinary Care in Grimes, IA (101 NE Circle Dr, Grimes, IA 50111). Breeder will provide vet care at the same location. The Guardian is responsible for transport to St. Francis Vet Care for all wellness appointments and needed care.

Distant Guardians (within 2-3 hours of Des Moines): The Guardian will provide Hill's Science Diet Large Breed Puppy Food until a year of age and then Hill's Science Diet Large Breed Dog Food. This can usually be found at Bomgaar's. The Guardian will provide vet care at a vet near their residence. They are required to keep the dog on monthly/yearly heartworm prevention (not ProHeart for females, Proheart okay for males) and Simparica or NexGard flea/tick prevention (no flea prevention when pregnant/nursing). They are required keep the dog current on DHLPP, Lyme, and rabies vaccines. The Guardian will also get the dog OFA x-rays, which the Breeder will pay for.

All Guardians: The Guardian shall provide the dog with an adequate food, fresh water, shelter, affection, and medical care upon sickness, disease, or injury. Maintenance should include an annual health exam and routine vaccinations as recommended by a board-certified veterinarian. Humane care and maintenance in accordance with all current and future state, county, and municipal laws and ordinances where the Guardian resides. A fully fenced yard or other humane means of exercise. The dog shall not be kept chained or constantly outdoors. A collar and identification tag and/or microchip will always be on the dog. Never permit the dog to roam unattended.

- The dog shall reside with the Guardian and may not be spayed or neutered.
- The Guardian shall notify the Breeder immediately if the dog cannot be kept by the Guardian.
- The dog shall not be sold, transferred, or given to any individual or to any retail or wholesale establishment for the purpose of sale or resale to the public or to any research institution where medical experimentation or other practices take place.
- The Guardian and Breeder agree to keep each other informed of their current addresses.
- The Guardian agrees that it is the Guardian's responsibility to accept the dog as described. The Breeder has provided and the Guardian has acknowledged a full disclosure of the health, habits, and temperament of the dog. The dog's health records, from St. Francis Veterinary Care, can be supplied.
- If the dog has been injured or harmed due to negligence, the Guardian is responsible for up to \$3,000 to be paid to Allison O'Grady within 2 weeks.

- The Guardian may return the dog to the Breeder at any time and for any reason.
- The Guardian will act reasonably to prevent unplanned breeding of the dog. Plans
 must be made with the Breeder. If there is an accidental breeding of the dog, a
 \$2,100 fee plus the sale value of all resulting puppies shall be paid to Allison
 O'Grady within two weeks of the dog giving birth or siring a puppy.
- Male Dogs: The Guardian may propose breeding matches to the Breeder and will have any mate gene tested and hip and elbows checked with OFA or Penn Hip x-rays. If the dog has a merle gene, it will not be paired with another dog with a merle gene. Both dogs will be tested for brucellosis. The Guardian will receive half of the profits and the Breeder the other half (usually \$550 each/\$1,100 total).
- Male Dogs: The Breeder may use the dog for breeding purposes at any time with at least 24 hours notice (local guardians). For distant guardians, the Guardian will receive ¼ of profits for matches set up by the breeder. They will need to transport the dog to a local match or the match has to come to them.
- Female Dogs: The Guardian may propose breeding matches to the Breeder and will have any mate gene tested and hip and elbows checked with OFA or Penn Hip x-rays. If the dog has a merle gene, it will not be paired with another dog with a merle gene. Both dogs will be tested for brucellosis. The Guardian will raise the litter and receive 80% of the profits from the litter.
- Female Dogs: The Breeder may match the dog (spring/summer litters only if preferred by the Guardian) and the Guardian agrees to raise the litter if they would like. The Guardian will receive 3/4 of the profits from the litter.
- Female Dogs with Guardians that cannot raise a litter (local only): The Guardian agrees to allow the Breeder to keep the dog temporarily for breeding and whelping purposes. No profits are shared in this scenario.
- No Guardians more than 2-3 hours away from Des Moines for female dogs if they don't plan to raise litters at the Guardian's residence.
